BACKGROUND TO THE CONFERENCE

April 1st Executive Order: Statewide mandatory water restrictions - Implementation challenges

The enduring California drought gives focus to groundwater management legislation (SGMA) and an April 1st executive order to reduce use. As water scarcity persists there are increasing challenges to resolving water rights and allocation priorities. Local implementation of SGMA legislation is a work in progress statewide. The rights to use and the authority to allocate what little water there is will be fiercely contested and defended. While the drought brings “quantity” issues to the fore, resolving groundwater “quality” issues continues as a major challenge. This conference will provide perspectives from top legal and management experts about effective ways to resolve some of these critical issues.

Attendees will gain insight about legal strategies and management innovations that are likely to be relevant to communities and end-users statewide in the conflicts among competing demands for water and as solutions to contamination issues.

The target audience for this event includes attorneys, water utility and water district staff, City/County staff and Commissioners, State and Federal regulators, water engineers and consultants, academics, environmental NGOs and anyone else interested in legal issues affecting groundwater-rights, ownership, protection and use.

STATEWIDE MANDATORY WATER RESTRICTIONS: IMPLEMENTATION CHALLENGES



Gordon Burns was appointed by Governor Brown in December 2011. Prior to his appointment, Gordon spent most of his career in the California Attorney General's Office, where he focused on complex natural resources cases, writs, and appellate practice. From 1999 to 2006, he was a Deputy Attorney General in the Land Law Section, representing clients in cases involving regulatory takings, the California Environmental Quality Act, the restoration of the Lower Owens River, and the CALFED Bay-Delta Program. Beginning in 2006, he served as Deputy Solicitor General, supervising all of the State's civil cases in the Supreme Court. From 2010 until his appointment as Undersecretary, Gordon was an attorney at the Resources Law Group, where he led the firm's climate change, land use, and transportation program.

Gordon holds a degree in history from the University of California Los Angeles and a law degree from the University of California Hastings College of the Law.

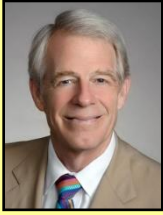
