

NY PFAS Webinar Continuing Education Requirements

State of NY Water Operator and Wastewater Treatment Plant Operator:

- A short multiple choice and true/false exam will be given at the end of the webinar. You must score at least 75% to receive continuing education credit.
- Attendee must complete and sign the AGWT Continuing Education Form (see below)

Upon receipt of exam and completed AGWT Continuing Education Form, the AGWT will issue you a Certificate of Attendance for the webinar.

State of CT LEP:

- A short multiple choice and true/false exam will be given at the end of the webinar. You must score at least 75% to receive continuing education credit.
- Attendee will be monitored (via long-in on Zoom) and must attend for at least 90% of the webinar
- Attendee must complete and sign the AGWT Continuing Education Form (see below)

Upon receipt of exam and completed AGWT Continuing Education Form, the AGWT will issue you a Certificate of Attendance for the webinar.

State of NJ LSRP:

- A short multiple choice and true/false exam will be given at the end of the webinar. You must score at least 75% to receive continuing education credit.
- Attendee must complete and sign the AGWT Continuing Education Form (see below)
